IUFRO (Unit 3.06.00) Workshop on:

Forestry utilization in Mediterranean countries with particularly respect to sloping areas



INTRODUCTION

The Mediterranean basin has always represented a meeting place of different races and cultures and it has been the cradle of civilizations which have molded the evolution of African and European Continents.

Also from forestry point of view the Mediterranean area represents a hinge between the temperate forests and the tropical ones, showing peculiarities and specific characteristics both from vegetation terms and from the risks it is subjected to (soil erosion, desertification, wildfires).

Those characteristics, together with the social and economic ones that distinguish the Countries which face Mediterranean Sea, affect the forest management and the forest utilization systems.

*In order to weight up the present conditions and to consider the probable evolution in the forest utilization sector, with main reference to the forests in mountainous area, Unit 3.06.00 - Forest operations under mountainous conditions of Division 3 - Forest Operations Engineering and Management of International Union of Forest Research Organizations (IUFRO) organize, in the frame of the **33rd CIOSTA Conference** (Commission Internationale de l'Organisation Scientifique du Travail en Agriculture) that will be held in Reggio Calabria (Italy) from June 17 to June 19, 2009 at "Mediterranea" University, a workshop where the researchers of the Countries which faces the Mediterranean Sea, are invited to.*

OBJECTIVES AND SCOPE OF THE WORKSHOP

The workshop will be the opportunity to exchange experiences and share information on the state of the art of knowledge for the improvement of forestry utilization in Mediterranean countries in respect to the new trends in harvesting and wood transport. The overall objective of the workshop is to offer a bridge between advanced scientific methods with modern information technologies to the practical engineering and operations through the workshop sessions and direct contacts among participants who will spread the information in their countries.

It is expected that the workshop will yield to the conclusions and recommendations that will be of particular importance for the countries where forest utilization is in the development and/or the wood based industry is challenged by the global economy.
